## About the YPDWMG

The Yadkin-Pee Dee Water Management Group was formed in 2016 by a workgroup of 13 parties -- governmental, public water utility, and reservoir operators – that provide service within the Yadkin-Pee Dee River Basin. The YPDWMG now has 18 members and continues to grow.

Our purpose is to enhance the welfare of Yadkin-Pee Dee residents by jointly planning for the sustainable use of water from the Yadkin-Pee Dee River Basin. Our overarching goals are:

- ❖ Comprehensive and collaborative regional planning
- ❖ Effective management of the river basin
- ❖ Optimize water supply resources
- ❖ Facilitate broad support and a unified regional voice for water supply needs
- ❖ United regional approach to drought response

YPDWMG provides a collaborative structure to coordinate projects and explore mutually beneficial ways to protect and develop our water supply – and save money and time.

## Tactical Actions and Leveraging Private Funding

We are working closely with the NCDEQ on developing a hydrologic model for the Basin. The stakeholder workshops for the Water Supply Master Plan (WSMP) were completed in 2019. We have established a Stakeholder Advisory Committee for the WSMP to maintain stakeholder engagement through the development and implementation of the plan. We have received a significant private grant to support this work and are coordinating with the state to provide additional technical support and financial support. In addition, we have recently incorporated as a 501(c)3 and are now eligible to apply for significantly more funding opportunities to help us complete the Water Supply Master Plan (WSMP).
